This privacy policy fulfills the information obligation arising from Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR) (Official Journal of the EU L119, 4 May 2016, p. 1) (hereinafter referred to as GDPR).

1. Personal Data

Personal data – according to Article 4(1) GDPR – means any information relating to an identified or identifiable natural person (“data subject”). An identifiable natural person is someone who can be directly or indirectly identified, in particular by reference to an identifier such as a name, identification number, location data, online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that person.

2. Data Controller

3. Source of Personal Data

We process your personal data obtained from the following sources:

a. The “Registration Agreement” you completed when signing up for a tourist service;

- b. Newsletter registration forms;
- c. Emails sent directly to us by you, including through contact forms;
- d. Telephone conversations and messages exchanged with you.

4. Legal Basis, Purpose, and Scope of Processing

The Data Controller processes personal data in accordance with:

- Article 6(1)(b) GDPR – processing is necessary for the performance of a contract to which the data subject is party, or to take steps at the request of the data subject prior to entering into a contract;
- Article 6(1)(c) GDPR – processing is necessary for compliance with a legal obligation to which the Data Controller is subject;
- Article 6(1)(f) GDPR – processing is necessary for the purposes of legitimate interests pursued by the Data Controller or a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject, in particular if the data subject is a child;
- Article 6(1)(a) GDPR – based on the consent of the data subject for marketing purposes.

The Data Controller processes personal data for the following purposes:

- a. Performance of a tourist service agreement;
- b. Accounting and tax settlements;
- c. Maintaining a register of tourist service contracts, as required by the Act on Tourist Services and the Tourism Guarantee Fund Act;
- d. Marketing purposes based on explicit consent.

Data is processed only to the extent necessary for these purposes and for the period necessary to perform the contract or until consent is withdrawn.

Data may be shared with entities legally entitled to receive it, including courts, transport companies, insurance companies, hosting providers, external accounting services, subcontractors providing tourist services, and, with user consent, for marketing purposes.

5. Data Collected

For the purposes of providing tourist services or handling inquiries, we collect:

- Full name
- Residential address
- Date of birth
- PESEL number

- Email address
- Phone number
- Identification document number (ID card or passport)
- Emergency contact information (name, surname, and phone number)

For newsletter communication, we collect your name and email address. Providing personal data is voluntary but necessary for participation in tourist services, receiving newsletters, and information about new destinations or trips.

Data is retained only as long as necessary to:

- Handle your inquiry;
- Process your registration for a tourist service or event;
- Comply with legal obligations (tax and accounting purposes);
- Honor your marketing consent (until withdrawn);
- Fulfill contractual obligations (until the contract expires).

Data is stored for no longer than six years after the service provision ends.

6. User Rights (Articles 15–22 GDPR)

Right of access (Art. 15 GDPR): Users can request confirmation whether their personal data is being processed and obtain a copy.

Right to rectification (Art. 16 GDPR): Users can request immediate correction of inaccurate data.

Right to erasure (“right to be forgotten,” Art. 17 GDPR): Users may request deletion if:

- Data is no longer necessary for the purpose it was collected;
- Consent has been withdrawn;
- The user objects to processing and there is no overriding legal basis.

Right to restriction of processing (Art. 18 GDPR): Users may request restriction if:

- Data is inaccurate (until corrected);
- User objects to processing (pending review of lawful basis);
- Processing is unlawful and user requests restriction instead of deletion.

Right to data portability (Art. 20 GDPR) and Right to object: Users may object to direct marketing processing at any time.

Requests can be sent to team@gofishingeurope.com. For identification, the request should be sent from the registered email address or by registered mail to the company address. The Controller responds within one month. Complaints may be lodged with the supervisory authority.

7. Additional Information

The Data Controller ensures:

- a. Data is processed lawfully;
- b. Data is collected for specified purposes;
- c. Data is accurate and relevant;
- d. Data is stored only as long as necessary.

The Controller applies technical and organizational measures, including encryption, to protect personal data from unauthorized access, processing, alteration, loss, or destruction.

In cases of misuse of services against regulations, the Controller may process necessary data to establish responsibility, retaining messages as evidence.

8. Profiling

During website visits, data such as IP addresses and browser type is automatically collected for technical and administrative purposes. IP addresses may also be used for statistical demographic information.
